1 Introduction

3 Training aim and Objective

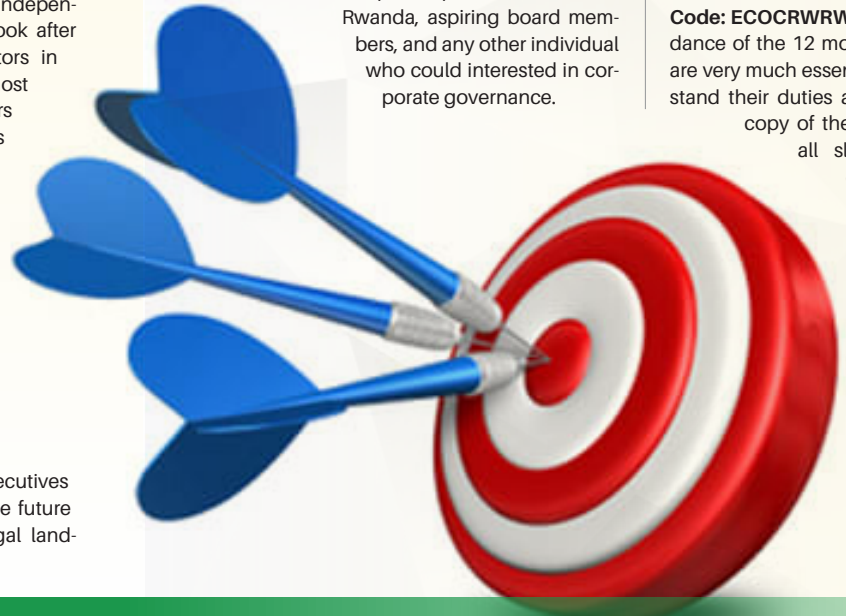
