This year, the Institute continues to encourage organisations to embrace the IFRS sustainability reporting as well as recognising individuals or organisations that have contributed to the development of the accountancy profession in Rwanda and beyond.

And thus, the rationale for including the following other categories: CFO of the year; CPA of the year; Young CPA of the year; Exceptional Female Accountant of the Year; as well as CPA fellowship to members who will have met the set criteria.
